This Privacy Notice explains how Happy Tails Dog Training collects and uses your personal information through our website in providing services to our clients and in dealing with our service providers. Happy Tails Dog Training takes its responsibilities for your personal information seriously and is committed to protecting your privacy. We would like you to understand how we collect and use your personal information. This Privacy Notice tells you what to expect when Happy Tails collects personal information from you.

Personal information we collect

When we refer to "personal information" in this Privacy Notice, we mean any information that relates to an identified or identifiable individual.

We collect the following kinds of personal information:

- Information we receive from others, for example, your dog's veterinary surgeon, in relation to our provision of services to you

How we use your personal information

We use the personal information that we collect about you in the following ways:

- To assist in the provision of our services to you
- For invoicing and payment purposes
- For internal record keeping
- To evaluate your experience and improve the quality of our services
- To receive services from our service providers and administer our relationship with them
- To enforce our contractual and other rights

How we collect and store your personal data

- Your personal information is gathered from the details you provide during your initial enquiry by telephone, email or online submission
- Your details may be held on computer, mobile device or on paper and are stored securely

How we disclose your personal information

We disclose your personal information:

- To third parties (such as your dog's veterinary surgeon) as necessary in providing our services to you
- In order to comply with applicable law and regulation
- To enforce our contractual and other rights

How long we keep your personal information

Your personal information will be retained for as long as is necessary to provide our services to you or for as long as we reasonably require to retain the information for our lawful business purposes or in order to comply with a statutory or other legal requirement. Your personal information will then be deleted or physically destroyed.
